NPCI – BANK – Aadhaar Linkage

The scholarship amount is sent to the bank account linked to the student's Aadhaar in the NPCI database **for all union government-sponsored scholarships**. This is known as DBT. (Direct Benefit Transfer). **This applies to all union government scholarships and some state government scholarships only.**

1. How to check if your bank account is linked to Aadhaar in NPCI database:

- a. Visit <https://myaadhaar.uidai.gov.in/>
- b. Login using Aadhaar No & OTP
- c. Click on "Bank Seeding Status."
- d. If it shows the "Bank Name" and status as "Active", everything is okay. Ensure you use the bank's savings account mentioned on this page at least once every two years. The union government scholarship amount will be credited to this account.
- e. **Follow the steps below if it shows "No Bank Seeded" or "Inactive" or a bank name you don't recognise.**

2. How to link your bank account to the Aadhaar-NPCI database:

- a. Some banks like Axis & HDFC offer the NPCI Aadhaar Bank Linkage option in their Internet Banking Facility itself. You may use those. If available, skip to point 2.f
- b. Visit your bank branch where you have an account with the following documents:
 1. Aadhar card
 2. Bank Passbook
 3. Aadhaar Linked Mobile Number
 4. They might ask for fingerprint authentication
- c. Remember to mention this to the bank officer:

"I want to do NPCI-Aadhaar linking for this bank account for DBT scholarship transfers."
- d. This is usually a free-of-charge service in most banks.
- e. You can do this with any of your bank accounts. It doesn't have to be the loan-availing bank.
- f. 3 days after submitting the request for linkage in the bank, check the UIDAI link provided in point 1. to check if it has been linked correctly for confirmation.

The link should show "Bank Name" & "Active."

Frequently Asked Questions

1. Can I avail more than one scholarship?

Yes, IIMA allows students to obtain more than one scholarship, but the total amount should be lower than the fees paid over two years and reasonable living expenses. **But kindly note** that some scholarships of central and state governments have a condition that you should not receive any other scholarship if you receive their scholarship.

2. What does only one scholarship rule mean?

If the rule says yes, you should not receive any other scholarship if you are selected for that particular scholarship. If you had previously received any other scholarship, they should be returned.

3. What is “yes, but restriction only on other central & state government scholarships”?

If you are selected for that scholarship, you should not receive any other government scholarships, but you are allowed to receive any institute or private foundation scholarships. This is a modified version of only one scholarship rule.

4. What does the “only for 1st PG” rule mean?

Some scholarships have a rule that the student is eligible for the scholarship only if this current MBA course is his/her first Post Graduate Degree. This will make students who had previously completed another PG degree programme or Integrated BS-MS programme ineligible for this scholarship.

5. What does “Based on SNBS scholarship” mean?

Some alumni-sponsored scholarships don't have a separate application or eligibility criteria. An application submitted for the SNBS scholarship will also be considered while deciding on these scholarship awards. Additional steps may be involved.

6. What does Female Reservation in scholarship mean?

Some scholarships earmark a particular percentage of the total slots/number of scholarships to be awarded, specifically for female students. This means if there are 10 scholarship slots under a particular scholarship with 30% reservation for female students and 15 students have applied, then the 15 students will be ranked based on merit. The first 7 slots will be filled with the top 7 out of the 15 students, which may also include female students. Then, the female students out of the remaining 8 will be ranked based on merit; the top 3 female students in this list will be allotted the 3 slots. In brief, 70 slots will be open competition and 30% reserved competition for female students based on the example.

7. Does the student have to be a resident of a state to avail of the state government scholarship?

Yes. Residence will need to be proven through a nativity certificate or ration card.

8. Are there scholarships specifically for female students?

Yes, three scholarships are only for female students. They are:

10. Under the NSP Portal, I have filled out the form, but it shows “no eligible scholarships”. What to do?

You must select “MBA – 2 Years” under the course option. Do not choose PGP.

11. What does “Not Applicable” mean?

It means that the particular criteria do not apply to the scholarship. For example, if it is mentioned as “Not Applicable” for “Maximum Annual Family Income”, then there are no income criteria for that scholarship.

12. What does “information Not Available” mean?

Some scholarship sponsoring agencies do not necessarily release all the information to students, such as the number of scholarships or the selection criteria. The information not available to us for these scholarships has been mentioned above. However, we are constantly trying to update the status by getting the required information through various channels. Hence, a revised version of this scholarship guidebook may be expected.
